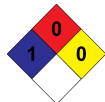

### SECTION 4: FIRST-AID MEASURES

#### 4.1 Description of necessary measures:

### SECTION 5: FIRE-FIGHTING MEASURES

#### 5.1 Suitable (and unsuitable) extinguishing media:

Product is non-flammable under normal conditions of storage, manipulation and use.
